Fee and reservation information

- Entry Fee, Autos (\$2500):** Fee for one auto and 2 drivers, including accommodations (double occupancy) and banquets.
- Entry Fee, Cycles (\$2250):** Fee for one motorcycle and driver, including accommodations (double occupancy) and banquetst.
- Third Driver, Autos (\$500):** Additional fee for a 3rd driver or team member
- Entry deposit (\$250):** This will reserve a starting position, and apply in full against total fees above. This deposit is refundable through December 31, 2001.
- Starting position:** Car numbers will be assigned within group (auto or cycle) in the approximate order that entries are received, with a few numbers reserved for past Alcan winners and factory teams.
- Advertising waiver (\$500):** Fee for the waiver of the event's advertising display requirements (see regulations for details).
- Refund policy:** Entry fees are fully refundable through July 1, 2002. After that date refunds will be 50% in cash and 50% in the form of a credit towards a future Alcan event.
- Visa, Discovery, and Mastercard** are accepted. All fees must be paid in full by June 1, 2002.
