

PERSONAL RELEASE

If, for any reason, pursuant to any relevant copyright laws anywhere in the world, the results and proceeds of my services or materials, any elements of the Program or any derivative works thereof are deemed not to be a work-made-for-hire, I agree that this Personal Release constitutes an irrevocable, perpetual assignment to Producer of any and all of my right, title and interest therein under any such relevant copyright laws, in all languages, formats, manner and media now known or hereafter devised, throughout the Universe and in perpetuity, including without limitation any and all worldwide copyrights and renewals, extensions and restorations thereof, and of all rights in all derivative works based upon the Program, including without limitation the advertisement, promotion, packaging, publicity, distribution, exhibition and/or other exploitation thereof, and including all ancillary and subsidiary rights therein.

I hereby release, indemnify and hold Producer harmless from and against all liability and obligation (including reasonable attorneys' fees) to me of any kind or nature whatsoever arising out of or in connection with the exercise of the rights granted hereunder, including without limitation from any liability for violation of rights of privacy, publicity, defamation, or any other right of any person or entity. I further release, indemnify and hold Producer harmless against all claims, actions, losses, damages, judgments and liabilities (including reasonable attorneys' fees) resulting from any breach or alleged breach of this Personal Release by me.

In no event shall I have any right to terminate the rights granted to Producer hereunder or to enjoin, restrain or otherwise interfere with the development, production, distribution or other exploitation of the Program or any other materials or productions produced or contemplated hereunder. This is the entire agreement between the parties and cannot be modified without Producer's written consent. This agreement shall be exclusively governed by and construed in accordance with the internal laws of the State of California. I warrant and represent that I am not a member of any guild, union or other talent association having jurisdiction over my services rendered hereunder. I understand and agree that in no event shall Producer be under any obligation to utilize or exercise any of the rights, licenses or privileges described above.
